



## UK CAR EVENTS LTD | EVENT Terms & Conditions

*TRADERS & EXHIBITORS and please sign and date on the dotted line and return.*

UK Car Events Ltd will be referred to as the “Event organiser’s’ and or UK Car Events” throughout the following terms and conditions.

UK Car Events Ltd is a company registered in England and Wales under company number 14198133 and whose registered address is at 1A Bonington Road, Nottingham, NG3 5JR. Uk Car Events is the event organiser.

UK Car Events Ltd reserves the right to amend and update the terms & conditions at any time where it has valid reason to do so.

### **1.0 - TICKETS AND ADMINSSION**

1.1 All tickets are non-transferable. Tickets must only be used for personal or private use. If the ticket is resold or transferred for profit or for commercial benefit or gain or as part of any hospitality package or similar arrangement by anyone without **UK CAR EVENT'S** authority it will become void, and the holder may be refused entry to or ejected from the Event and/or the Venue.

1.2 Up to two child tickets are available for children aged 15 years and under with each paying adult. The Event Organiser’s reserve the right to require photographic evidence of proof of age should they feel it is necessary. Children must always be accompanied by an adult.

1.3 The Event Organisers reserve the right to refuse admission and to remove persons from the event who do not comply with the event rules or these terms and conditions, who represents a security risk, nuisance or annoyance to the staging of the Event or who have in his or her possession prohibited items, which shall include but not be limited to alcoholic beverages, illegal drugs, chemicals of any kind, glass bottles, barbeques, ladders, laser pens, weapons or any offensive materials in whatever format. The Event Organisers further reserve the right to conduct security searches of persons and their belongings to ensure the safety of persons at the Event. Pass-outs and re-admissions into the event shall be granted at the Event Organiser’s discretion. Re-admission shall only be possible if a valid official pass-out is presented.

1.4 Tickets will be dispatched to general admission ticket holders immediately after payment has been processed via E-mail. **UK CAR EVENTS** will not be liable for lost tickets.

1.5 Each person entering the event by general admission or within a vehicle must be in possession of a valid entry ticket. Any person not in possession of an entry ticket must purchase a ticket or will otherwise be refused entry to the Event.

1.6 All tickets purchased are non-refundable.

1.7 No animals (with the exception of registered assistance dogs) are permitted into the event unless stated otherwise on the website.

1.8 Please keep your ticket safe and in good condition as a duplicate ticket will not be issued if it is lost or stolen. A defaced or illegible ticket may become invalidated. **UK CAR EVENTS** will not be liable for any lost or stolen tickets and are not obliged to re-issue such lost or stolen tickets.

## **2.0 – DATA PROTECTION**

2.1 All personal data will be looked after in accordance with General Data Protection Regulations (GDPR)

## **3.0 – DISPLAY / SHOW VEHICLES / ATTENDING CARS**

3.1 All vehicles to be displayed within the event must have a vehicle pass and must be placed within the confines allocated space. Vehicles displayed outside the allocated will have to be moved by the Event Organisers to either the confines of the allocated space or to the official car park.

3.2 All drivers of display or show vehicles will each require a car pass and a ticket.

3.3 All drivers of display vehicles will each require a car pass and a ticket.

3.4 All Display / Show car drivers must follow **UK Car Events** staff instructions throughout the event, failure to do so may result in the car and driver being asked to leave.

3.5 The Venue operates a 5mph speed limit within the park and this is governed by the law of England & Wales. The Highway Code is still applicable within the Venue

3.6 Any vehicles and drivers found speeding or endangering the public will be recorded and reported to the police and asked to leave by **UK Car Events Ltd** and will forfeit their rights to a refund and banned from attending any other events hosted by **Uk Car Events Ltd**.

**3.7** Any vehicles over revving or making excessive noise without constant form **UK Car Events Ltd** will be asked to stop, leave or may even face being banned in some cases.

## **4.0 – EVENT ACTIVITES**

4.1 Motor racing is dangerous and noisy and ticket holders acknowledge that they may be exposed to possible risk of physical harm due to the nature of the Event. **UK Car Event Ltd** and their contractors are not responsible for any loss or damage howsoever caused to ticket holders, to the maximum extent permitted by law.

4.2 During the Event the noise level may be very loud within the Venue. Ticket holders are advised to wear hearing protection during races and live concerts (if any) to reduce the risk of hearing damage.

4.3 All persons entering the event's shall co-operate by complying with venue rules and guidelines by stewards, marshals, safety personnel and other legally authorised persons. This includes producing a valid entry ticket upon request, submitting to inspections and allowing removal of unauthorised objects.

4.4 Photographs taken at events are only for use in editorial press publications (with correct crediting of the event). It is strictly forbidden to use these photographs for commercial purposes. Any other use must be discussed with the Event Organisers before the event. Failure to comply with these conditions may result in legal action.

4.5 CCTV and film cameras may be present at the events, this includes filming by the police or security staff carried out for the security of visitors, and filming and/or photography by Event Organisers. By purchasing a ticket to the Event and/or attending the event you give your express consent to all such filming and to your actual or simulated likeness being included within any film, photograph, audio and/or audio visual recording ("Footage"), all rights in which will be owned by Uk Car Events Ltd or the relevant third party. You also agree that any such Footage may be used by the Event Organiser in any and all media for any purpose at any time throughout the world, including (with the exception of CCTV or security Footage) for commercial purposes, without payment or compensation to you. ## 5.0 – LIABILITY

5.1 **UK Car Events** will not be liable for any loss, injury or damage, howsoever caused, to ticket holders or their property ("Loss") except where and only to the extent that any such Loss is caused by the negligence of Kelsey Publishing Ltd, its employees or authorised agencies.

5.2 Any vehicles left at the venue for longer than the event day will be moved by the owners of the venue unless **UK Car Events** have been advised and permission has been obtained. If vehicles are left overnight, it is the owner's sole risk and **UK Car Events Ltd** cannot accept liability.

5.3 **Uk Car Events** reserve the right to request ticket holders to leave the event at any time for safety reasons or immediately after the event. Re-admission will not be granted at the end of the event.

5.4 Any venue damage, damage to property or Vehicles not owed by the offered that caused said damage will be liable to pay for the cost of repairs or any fines issued to **UK Car Events Ltd** by the venue or property owner. **UK Car Events Ltd** will not be held responsible for any damage caused by anyone outside of our control.

## 6.0 PROHIBITED ACTIVITIES

6.1 Under no circumstances will auctioning, pitching, fundraising, raffles, tombola, canvassing or pick-a-ticket stands be allowed at the Event without the written permission of the Event Organisers.

6.2 The following are not allowed on the Event Site at any time: Animals; glass/bottles; bonfires; barbecues; drones, mini motos, trikes, bikes scooters or quads. Anyone found entering the event with what has been listed could be asked to leave.

## 7.0 CAR PARK TERMS AND CONDITIONS

7.1 All vehicles (and their contents) parked at the event are left at the owner's sole risk. The Event Organiser shall not be liable for any loss or damage suffered by owners (including damage to owners' vehicles and/or their contents), except where and only to the extent that such loss or damage is caused by the negligence of **UK Car Events Ltd**, its employees or authorised agents. **UK Car Events Ltd** reserves the right to move any vehicle it deems necessary due to logistical, safety or similar reasons.

7.2 It is a condition of admission to the venue that no animals are allowed within such areas and owners acknowledge that the Event Organisers personnel or their appointed contractor shall be entitled to enter any vehicle by whatever means necessary at the owner's cost in the event that

any animal has been left within a vehicle.

7.3 Owners and passengers alike must at all times act responsibly and with due regard to safety whilst in any of our event car parks (either on foot or whilst driving). The Event Organisers reserves the right to refuse admission and/or eject any person(s) found in breach of these conditions or the conditions of entry into the event.

## 8.0 UNFORSEEN EVENTS

8.1 Unforeseen Event means anything outside the reasonable control of **UK Car Events Ltd**, including but not limited to, acts of God, adverse weather conditions, fire, storm, flood, earthquake, explosion, accident, acts of the public enemy, war, rebellion, insurrection, sabotage, epidemic, quarantine restriction, labour dispute, labour shortage, power shortage, ceasing to be entitled to access the internet for whatever reason, server crashes, deletion, corruption, loss or removal of data, transportation embargo, failure or delay in transportation, any act or omission (including laws, regulations, disapprovals or failures to approve) of any government or government agency.

8.2 If the Venue becomes unfit or unavailable for occupancy or shall be substantially interfered with by the occurrence of an Unforeseen Event and **UK Car Events Ltd** decides, in good faith, that the Event cannot go ahead on the date stated in the Booking Form, then **UK Car Events** obligation to perform in accordance with the Contract will be suspended and **UK Car Events Ltd** shall decide, in good faith, whether the Event is to be cancelled, relocated or postponed to another date. **UK Car Events** shall inform the ticket holder of such occurrence and its decision to cancel, relocate or postpone the Event as soon as practicable after the Unforeseen Event, and the ticket holder waives any claims it might have against **UK Car Events** for refunds, damages or expenses. If **UK Car Events** decides to relocate or postpone the Event it shall provide such details to the ticket holder within a reasonable period.

## 9.0 TRADERS & EXHIBITORS

9.1 Traders and exhibitors will received all relevant information regarding to setup and breakdown by UK Car Events Ltd before the events date

9.2 Trading of goods and services during the event is allowed by **UK Car Events** Ltd approved and paying traders & exhibitors however must be carried out only in the traders & exhibitors designated space.

9.3 Any Trading of goods and services during the event by **UK Car Events** Ltd approved and paying traders & exhibitors and customers understand that **UK Car Events** cannot be held responsible for anything out of our reasonable control.

9.4 In order to exhibit and trade at **UK Car Events Ltd** event all must have fully paid any outstanding invoice from **UK Car Events** before the Invoices due date.

9.5 All Traders and Exhibitors require valid 5 million public liability insurance, **UK Car Events Ltd** have the right to request proof of this before and during the event, if Trader or Exhibitor is unable to supply this they will be asked to leave the event and forfeit their right to any refunds.

9.6 All Traders and Exhibitors must insure their designated space is safe and all precautions are taken to insure the safety of the public attending the event. **UK Car Events LTD** hold the right to remove or secure any object that we deem as a hazard to the public

9.7 Once a pitch has been paid for and allocated by the Organisers, a trader or exhibitor reducing or cancelling their application for that pitch less than 8 weeks prior to the show will be liable for 50% payment. Traders cancelling space less than 5 weeks prior will be charged the full rate.

9.8 Exhibitors and Traders must accept responsibility for any damage they, their staff or contractors, cause to the fabric of the building, land or property belonging to the Venue. Any damage shall be made good at the registered Exhibitor's or traders expense to the entire satisfaction of the management of the Venue and the Organisers.

9.9 Traders, Exhibitors and their staff must carry out business and conduct themselves in a manner not objectionable to other Exhibitors, visitors or the Organisers. In the event of this regulation not being observed, the Organisers shall be entitled forthwith to terminate the Exhibitor's license to occupy the stand

**10.0 Terms and Conditions – Review**

10.1 By purchasing a ticket or by applying and paying for a Trade Stand or Exhibitor space the ticket holder, any Trade Stand or Exhibitor staff agrees to these Terms and Conditions.

10.2 Any ticket holder, any Trade Stand or Exhibitor staff found in breach of any the above terms and conditions will be dealt with by **UK Car Events Ltd**, venue staff or local authorities if required.

10.3 The Organisers reserve the right to waive, add, or alter any of these Terms and Conditions in the interests of the Show either generally or in any particular case. The Exhibitor or ticket holders will be notified of any waivers, additions, or alterations in advance of the Show. Should any question arise, whether provided for in these Terms and Conditions or not, the decisions of the organisers shall be final and binding on each.
